**General Rules**

**001 Application of Ocean and Terminal Services**

1. This publication applies for UPS Freight (also identified as Carrier) and explains the rates, rules and charges for offshore services subject to other publications, pricing agreements or individual customer contracts. Exceptions to any of the items in this publication will be noted in customer specific pricing agreements, statements of agreed pricing or contracts that apply for individual customers. UPS Freight, in accordance with its obligations under the Interstate Commerce Commission Termination Act, Section 13710, shall provide to the shipper, on request of the shipper, this publication or any other written or electronic copy of the rate, classification, rules, and practices upon which any rate applicable to its shipment or agreed to between the shipper and Carrier is based.
2. In an effort to provide its customers with quality service and competitive rates, certain commodities are shipped at less than full value. UPS Freight encourages its customers to review this publication as some items may be subject to limitations of liability, released values or other requirements which may relate directly to your shipment. Therefore, all shippers are further encouraged to evaluate their personal or corporate cargo insurance policies so they may ship their goods at the lowest possible rate while still being insured for full value.
3. Unless otherwise provided, when provisions of this tariff are in conflict with those published in individual contracts and / or tariffs, such contracts and / or tariffs, to the extent of their application, will apply.
4. Where a rule published in this tariff covers the same rule published in UPS Freight’s general rules tariff UPGF 102 series or the National Motor Freight Classification, NMF 100 series, such rule published herein, to the extent of its application, will apply in lieu of the rule published in UPGF 102 series or the NMF 100 Series.
5. Except as otherwise provided, or otherwise stated on the bill of lading, and unless the shipper has agreed to accept responsibility, additional charges for ocean and terminal services shall be collected from the party requesting or requiring the service irrespective of whether the line haul charges are prepaid or collect. In the event the party requesting or requiring the service does not pay or is unwilling to pay, UPS Freight reserves the right to assess the charges against the payor of the freight charges.
6. Reissued tariffs, items or parts of items will cancel previously issued tariffs, items or parts of items, or publications referenced thereto. The term “series” implies the most current tariff in effect at time of shipment. Where an item suffixed with an alphabet letter, the letter A, cancels the original item not so suffixed, B cancels A, C cancels B. etc.
7. Unless specifically indicated, the charges shown in this tariff are NOT subject to any discounts or reductions.
8. Where a rule or service is not found in this tariff, refer to UPGF 102 series.
9. Section 2 applies on shipments originating at or destined to points in Puerto Rico or the U.S. Virgin Islands.
10. Section 3 applies on shipments originating at or destined to points in Hawaii or Guam.
11. Section 4 applies on shipments originating at or destined to points in Alaska.

**012 Cross Dock Consolidation Service**

All shipments moving from the contiguous United States to offshore locations when dropped off at UPS Freight's terminal for consolidation shall be subject to a cross dock service charge. Carrier's charge for the service will be the larger of the minimum, the rate per hundred lbs (cwt) or the rate per cubic foot as follows:

**020 Redelivery**

Redelivery charges and terms will apply as outlined in Carrier's UPGF 102 Rules tariff in effect on the ship date, except as noted.

When shipment is subject to an island delivery charge, an island delivery will apply for each delivery attempt in lieu of applicable redelivery charge.

**023 General Discount**

Unless otherwise published, the following discount applies on the movement of shipments within the contiguous 48 United States or Canada:

Discount            73%

**Island Delivery Overflow**

Island deliveries for volume shipments will be limited to shipments weighing 42,000 pounds or less and consisting of 24 skids or less. In the event a shipment is tendered to UPS Freight, or its agent, exceeding 42,000 lbs or 24 skids the amount of the excess will be rated as a separate shipment.

**704 Island Delivery Fuel Surcharge**

A surcharge in the amount of 10% of the applicable island delivery/ pickup charge shall apply.

**705 Shippers Export Declaration Fee**

All shipments moving between the United States or Canada and Puerto Rico shall be subject to a Shipper Export Declaration preparation and processing fee of \$32.00 per shipment. Shipments moving between the United States or Canada and the U.S. Virgin Islands shall be subject to a Shipper Export Declaration preparation and processing fee of \$60.50 per shipment. This fee shall be in addition to all other charges and shall be assessed against the party responsible for the payment of the ocean line haul freight transportation charges.

If the shipper indicates the SED filing has been handled electronically clearly noting the AES XTN electronic filing number the Shipper Export Declaration preparation and processing fee shall be \$16.00 per shipment.

Note: SED fee will not be charged where the bill of lading shows the declared value of the items in the shipment that does not exceed a value of \$2,500.00 and/or notes the SED is not required.

**706-A Port Security Fee**

All shipments moving between the United States or Canada and Puerto Rico shall be subject to a Port Security Fee of \$29.00 per shipment. Shipments moving between the United States or Canada and the U.S. Virgin Islands shall be subject to a Port Security Fee of \$38.00 per shipment. This fee shall be in addition to all other charges and shall be assessed against the party responsible for the payment of the ocean line haul freight transportation charges.

**707 Documentation Fee**

All shipments moving between the United States or Canada and Puerto Rico or U.S. Virgin Islands shall be subject to a documentation fee of \$19.00 per shipment. If the freight is considered personal goods, non-commercial, or personal effects shipments, moving from private individual to private individual, not imported for sale or for any commercial, industrial, occupational, institutional, or other like use, the document fee will be \$54.00. The fee shall be in addition to all other charges and shall be assessed against the party responsible for the payment of the ocean line haul freight transportation charges.

**708 Lift Gate**

Exception to UPGF 102 ITEM 892: When Carrier is required or requested to employ mechanical loading or unloading devices, including hydraulic or electric lifting or lowering devices, to accomplish pickup or delivery, the following service charge will be assessed separately for the service at pick-up or delivery in addition to all other applicable charges.

**709 Inside Delivery / Handling freight to or from positions non adjacent to vehicle**

Exception to UPGF 102 ITEM 566: When carrier is requested or required to pickup or deliver from positions non adjacent to vehicle the service charge will be \$26.50 per shipment

**712 Residences**

Exception to UPGF 102 Item 753: When Carrier is requested or required to arrange for pick-up or delivery at a residence an additional charge will not apply.

**714 High Cost Alternative Route Fee**

Any shipment that cannot be picked up or delivered along Carrier's standard route due to compromised road access resulting from detours, road damage, construction, closure, weather, or similar conditions, will be assessed a premium of 50% of the current Island Delivery / Pickup charge stated in Item 703, in addition to standard charges.

**716 Hazardous Materials**

UPS Freight may accept shipments of hazardous materials or hazardous substances subject to all requirements of the U.S. Department of Transportation and the Environmental Protection Agency governing transportation of such commodities. Shipper shall comply with all governmental requirements including but not limited to any special labeling, packaging requirements and bill of lading descriptions. When tendered by Shipper and accepted by UPS Freight, such shipments shall also be subject to the following provisions:

Applicable Commodities under this rule – Any shipment containing commodities that are classified as hazardous by the Department of Transportation as published in the Code of Federal Regulations (CFR), Title 49 and by the United States Coast Guard.

Per Shipment Charge:     \$137.00

**Note:** If hazardous materials included on a single shipment must be split into separate groups (segregated) within the ocean vessel, this charge applies for each separate group.

**719 Notification**

Exception to UPGF 102 Item 647: Notification prior to delivery will not be charged on shipments destined to, or originating at Puerto Rico or the U.S. Virgin Islands.
